Audit working papers are used to support the audit work done in order to provide assurance that the audit was performed in accordance with the relevant auditing standards.

Providing an audit program. Documentation in an audit program provides places to indicate who performed audit procedures, date performed, reference to workpaper index and conclusions. Since this product is only a planning document and an audit program, other resources or professional standards should be consulted for:

Adding blank Microsoft Excel and Word workpapers Index for Workpapers CS If there are more than three years under audit, examiners must also use Form 4318-A, Continuation Sheet for Form 4318, Examination Workpapers Index. The workpaper system is designed to facilitate consistent organization of case files and eliminate duplication.

The workpapers are required to be identified by the appropriate Standard Audit Index Number (SAIN) and indexed in a logical order within each section so that others such as a reviewer or appeals officer, can easily follow the work product. A standard workpaper index must be utilized to organize electronic workpapers within IMS.

The audit supervision and documentation standards of both the ASB and the PCAOB require that the preparer and reviewer be identified in the audit documentation along with the date the work was performed (AU-C 230.09b-c or AS 1201.05c and AS 1215.06b); however, the standards do not require a second sign-off by a reviewer on every workpaper.

The workpaper will not be included in the binder when a new binder is created for the next period. You would choose this option if the workpaper is specific to this period and does not apply to the next. This option is not available for Trial Balance workpapers, which are automatically rolled forward to maintain trial balance links and reports.
