Foreign corporations that have never done business in New York State must give DOS: an Application for Authority, and; a \$225 filing fee. Foreign corporations currently or previously doing business in New York State must obtain the tax commissioner's consent that all tax returns due are filed and all taxes due are paid before applying for authority. To obtain this consent, call the New York State Tax Department Call Center at (518) 485-2639.

The New York State Education Department is responsible for setting student learning expectations (standards) for what all students should know and be able to do as a result of skilled instruction. Each local school district develops curricula based on these established standards.

Landes, 84 N.Y.2d 655, 662 (1994). Pursuant to GBL § 359-e(3)(c), the registration of brokers, dealers, and salesmen shall be for a period of four (4) years plus an additional ninety (90) days following the end of the four-year period. Thus, broker-dealer registration statements must be filed every four years.
